Short Title: 2026 Daniel Town Meeting Schedule

Purpose: To adopt the 2026 meeting schedule for Daniel Town Council, Planning Commission, and Board of Appeals.

Ordinance: Be it ordained by the governing legislative body of the Town that:

Meetings will be held at the Wasatch County Services Building, located at 55 South 500 East, Conference Room B, Heber City, Utah, and/or may potentially be conducted via electronic meetings.

Except for the September meeting, which will be held on the second Monday of the month due to the Labor Day holiday, the monthly Town Council meetings shall be held on the first Monday of each month at 6:00 PM.

The Daniel Planning Commission meetings will be held on the third Wednesday of each month at 7:00 PM.

The Board of Appeals will meet as needed at 7:00 PM, with the date and room assignment to be announced in the public notice.

The published schedule is subject to change by Town officers due to unforeseeable circumstances and will expire on December 31, 2026. Any Town officers are hereby authorized to provide notice of the schedule, meetings, meeting cancellations, and/or meeting date changes, and agendas for such meetings in accordance with the laws and the State of Utah. 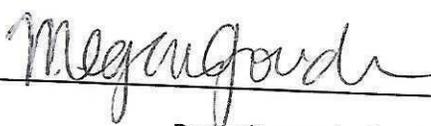
